2. Repair of Generator Set at the Administrative Service must be completed within thirty (30) calendar days upon receipt of the Notice to Proceed and Job Order.

4. Warranty Period shall be not less than one (1) year from the date of completion.
5. Proponent must submit, together with its Quotation, the following:

 - c. **Certified true copy** of the latest Income/ Business Tax Returns; and
 - d. **Original copy** of a **duly accomplished and notarized** Omnibus Sworn Statement (with Secretary's Certificate or Special Power of Attorney) in the form prescribed under the 2016 RIRR of RA 9184.
