3. Supply and Delivery of Sportsfest Supplies must be completed within seven (7) calendar days upon receipt of the Notice to Proceed and Purchase Order.
4. Supply and Delivery of Trophies must be completed seven (7) calendar days before the awarding ceremony.
5. Price validity shall be for a period of not less than sixty (60) calendar days from the date of quotation.
6. Proponent must submit, together with its Quotation, the following:
 - a. **Certified true copy** of Mayor's/ Business Permit;
 - b. **Certified true copy** of the proof of PhilGEPS Registration Number;
 - c. **Certified true copy** of the latest Income/ Business Tax Returns; and
 - d. **Original copy** of a **duly accomplished and notarized** Omnibus Sworn Statement (with Secretary's Certificate or Special Power of Attorney) in the form prescribed under the 2016 RIRR of RA 9184.
7. Considering that time is of the essence, the opening of quotations for examination of eligibility documents and the actual negotiation shall be conducted on the same schedule, thus, the presence of the proponent or its **authorized representative is a must during the negotiation/ opening of quotations**; otherwise, the submitted quotation will not be opened and the same will be considered ineligible for this project.
8. The proponent shall bring a sample of the proposed material for the uniform to be supplied.
