INVITATION TO BID
Supply and Delivery of DND-Wide POL Requirements for CY 2016

1. The *Department of National Defense (DND)*, with reference to the General Appropriations Act (GAA) intends to apply the sum of **Six Billion Forty Two Million One Hundred Seventy Eight Thousand Two Hundred Five and 31/100** being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of Petroleum, Oil and Lubricants (POL) CY 2016. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PROCURING ENTITY now invites Sealed Bids from Eligible Bidders for the procurement of POL. The description of an Eligible Bidder is contained in *Section II of the Bidding Documents, Instructions to Bidders (ITB)*.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act," and is restricted to Filipino citizens/sole proprietorships, and organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws and regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138). Only Bids from Bidders who pass the eligibility check will be opened. The process for the eligibility check is described in Section II of the Bidding Documents, ITB. The bidder with the Lowest Calculated Bid (LCB) for Lots 1 and 2 and with the Highest Rebate Percentage for Lot 3 shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during the post-qualification procedure.
4. Interested Bidders may obtain further information from the DND Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM Monday to Friday excluding holidays.
5. A complete set of the Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee in the amount of Seventy Five Thousand Pesos (PhP 75,000.00). The method of payment will be on a cash basis only. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.

6. The DND BAC will hold a Pre-Bid Conference open to all interested parties on **February 24, 2016 at 10:00 A.M., DND BAC Conference Room, Left Wing Basement, DND Bldg., Camp General Emilio Aguinaldo, Quezon City**. In case the said date of pre-bid conference and/or bid opening falls on a **Holiday, or a fortuitous event or was announced as a non-working day**, the said event will be held next Tuesday or Thursday following the initially set date of event. Late bids shall not be accepted.
7. Bids must be delivered on or before **March 08, 2016 at 10:00 A.M.** All bids must be accompanied by a bid security in any of the acceptable forms and in amount stated in ITB Clause 18.

Bid opening shall be on **March 08, 2016 at 10:00 A.M. at the DND BAC Conference Room, Left Wing, Basement, DND Bldg., Camp General Emilio Aguinaldo, Quezon City**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The DND BAC reserves the right to accept or reject any Bid, and to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
