INVITATION TO BID
JCPV PHASE 2 MARINE ENGINEERING UPGRADE (PS-37) PROJECT

1. The Department of National Defense and Armed Forces of the Philippines (DND/AFP), through the AFP Modernization Act Trust Fund intends to apply the sum of **TWO HUNDRED FORTY NINE MILLION SIX HUNDRED SEVENTY ONE THOUSAND PESOS** (Php 249,671,000.00) being the Approved Budget for the Contract (ABC) to payment under the contract for the **JCPV PHASE 2 MARINE ENGINEERING UPGRADE (PS-37) PROJECT**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The DND/AFP now invites bids for the **JCPV PHASE 2 MARINE ENGINEERING UPGRADE (PS-37) PROJECT**. Delivery of the Goods is required within **Three Hundred (300) Calendar Days** from Issuance of the Notice to Proceed. Bidders should have completed, within **Five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (Revised IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the Revised IRR of RA 9184.
4. Interested Bidders may obtain further information from DND-BAC Secretariat and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m. Monday to Friday excluding holidays.
5. A complete set of Bidding Documents may be purchased by interested Bidders on **April 05, 2016** from the address below and upon payment of a non-refundable fee for Bidding Documents in the amount of **FIFTY THOUSAND PESOS** (Php 50,000.00). It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.
6. The DND Bids and Awards Committee will hold a Pre-Bid Conference on **April 14, 2016 at 10:00 A.M.** at the DND-BAC Conference Room, Basement Left Wing DND Building, Camp General Emilio Aguinaldo, Quezon City, which shall be open to all interested parties who have purchased the Bidding Documents.

7. Bids must be delivered to address below on or before 01:00 P. M on **April 26, 2016** at the **DND-BAC Conference Room, Basement Left Wing DND Building, Camp General Emilio Aguinaldo, Quezon City**. All Bids must be accompanied by a Bid Security in any of the acceptable forms as provided in the bidding documents and in the amount stated in ITB Clause 18.

Bid opening shall be on **April 26, 2016 at 01:00 P.M.**, at the **DND BAC Conference Room, Basement Right Left DND Building, Camp General Emilio Aguinaldo, Quezon City**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. In case the said date of pre-bid conference and/or bid opening **falls on a holiday, or a fortuitous event or was announced as a non-working day**, the said event will be held on the next Tuesday or Thursday following the initially set date of event. Late bids shall not be accepted.
Late Bids shall not be accepted.

8. The DND/AFP reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders.
