INVITATION TO BID
**Procurement of One (1) Engine and One (1) Set of Gas Turbine
Generator for FA-50PH Aircraft**

1. The Department of National Defense/Armed Forces of the Philippines (DND/AFP), through the Philippine Air Force (PAF) General Appropriations Act CY 2016, intends to apply the sum of **FOUR HUNDRED NINETY ONE MILLION FIVE HUNDRED TWENTY FIVE THOUSAND PESOS (PhP 491,525,000.00)** being the total Approved Budget for the Contract (ABC) to payments under the contract for the procurement of the projects of the Philippine Air Force. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The DND/AFP now invites bids for the procurement of the following Philippine Air Force Projects:

3. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

4. Bidding will be conducted through Public Bidding procedures using non-discretionary "pass/fail" criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the RIRR of RA 9184.

5. Interested Bidders may obtain further information from DND Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the

address given below from 8:00AM to 5:00 PM Monday to Friday excluding holidays. A complete set of Bidding Documents may be acquired by interested Bidders on October 03, 2016 from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB.

6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

7. The DND BAC will hold a Pre-Bid Conference on **October 13, 2016 at 10:00 A.M.** at DND BAC Conference Room, Basement, Left Wing, DND Bldg., Camp General Emilio Aguinaldo, Quezon City, which shall be open to all interested parties who have purchased the Bidding Documents. In case the said date of pre-bid conference and/or bid opening **falls on a holiday, or a fortuitous event or was announced as a non-working day**, the said event will be held on the next Tuesday or Thursday following the initially set date of event. Late bids shall not be accepted.

8. Bids must be delivered to the address below on or before **October 25, 2016 at 10:00 A.M.** All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **October 25, 2016 at 10:00 A.M.** at DND BAC Conference Room, Basement, Left Wing, DND Bldg., Camp General Emilio Aguinaldo, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

9. The DND/AFP reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
