INVITATION TO BID

Supply and Delivery of DND-Wide POL Requirements for CY 2017

1. The *Department of National Defense (DND)*, with reference to the General Appropriations Act (GAA) intends to apply the sum of **Five Billion Nine Hundred Ninety Three Million Twelve Thousand One Hundred Two and 72/100 Pesos (₱5,993,012,102.72)** being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of Petroleum, Oil and Lubricants (POL) CY 2017. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **PROCURING ENTITY** now invites Sealed Bids from Eligible Bidders for the procurement of POL. The description of an Eligible Bidder is contained in *Section II of the Bidding Documents, Instructions to Bidders (ITB)*.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act," and is restricted to Filipino citizens/sole proprietorships, and organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws and regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138). Only Bids from Bidders who pass the eligibility check will be opened. The process for the eligibility check is described in Section II of the Bidding Documents, ITB. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during the post-qualification procedure.

The method of payment will be on a cash basis only. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.
6. The DND BAC will hold a Pre-Bid Conference open to all interested parties on _____, DND BAC Conference Room, Right Wing Basement, DND Bldg., Camp General Emilio Aguinaldo, Quezon City.
7. Bids must be delivered on or before _____. All bids must be accompanied by a bid security in any of the acceptable forms and in amount stated in ITB Clause 18.

Bid opening shall be on _____, at the DND BAC Conference Room, Right Wing Basement, DND Bldg., Camp General Emilio Aguinaldo, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
