## INVITATION TO BID

### Acquisition of One (1) Lot Cardiac-Catheterization Laboratory System, One (1) Lot Hyperbaric Chamber and One (1) Lot Magnetic Resonance Imaging for the Armed Forces of the Philippines Medical Center (AFPMC)

1. The Department of National Defense/Armed Forces of the Philippines (DND/AFP), through Special Allotment Release Order (SARO-BMB-D-16-0028778) intends to apply the sum of **Two Hundred Ninety Four Million Two Hundred Fifty Thousand Pesos (PHP 294,250,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Acquisition of One (1) Lot Catheterization Laboratory System, One (1) Lot Hyperbaric Chamber and One (1) Lot Magnetic Resonance Imaging for the Armed Forces of the Philippines Medical Center (AFPMC)**, broken down as follows:

The Contract will be awarded per lot. Bids received in excess of the corresponding ABC per lot shall be automatically rejected at bid opening.

2. The DND/AFP now invites bids for the **Acquisition of One (1) Lot Catheterization Laboratory System, One (1) Lot Hyperbaric Chamber and One (1) Lot Magnetic Resonance Imaging for the Armed Forces of the Philippines Medical Center (AFPMC)**. Delivery of the GOODS is required within a period abovestated **from the receipt of the Notice to Proceed**. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of similar contract is contained in the Bidding Documents, particularly under Section II. (Instructions to Bidders).

3. Bidding will be conducted through Public Bidding procedures using non-discretionary "pass/fail" criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA) 9184, otherwise known as the "*Government Procurement Reform Act*". Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the RIRR of RA 9184.
