INVITATION TO BID

Procurement of One (1) unit of Transmitter, FCR for the Unscheduled Maintenance of FA-50PH Aircraft

1. The Department of National Defense/Armed Forces of the Philippines (DND/AFP), through the Philippine Air Force (PAF) General Appropriations Act CY 2017, intends to apply the sum of **EIGHTY TWO MILLION FIVE HUNDRED FORTY THREE THOUSAND PESOS (PhP 82,543,000.00), Philippine Currency** being the Approved Budget for the Contract (ABC) as payment under the contract for the procurement of **One (1) unit of Transmitter, FCR for the Unscheduled Maintenance of FA-50PH Aircraft**. Bids received in excess of the ABC shall be automatically rejected at Bid opening.

2. The DND/AFP now invites Bids from eligible Bidders for the procurement of One (1) unit Transmitter, FCR for the Unscheduled Maintenance of FA-50PH Aircraft. Delivery of the GOODS is required within a period of **Five Hundred Forty (540) days** from receipt of **Notice to Proceed**. Bidders should have completed, within the last **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (Revised IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the Revised IRR of RA 9184.

4. Interested Bidders may obtain further information from DND-BAC Secretariat and inspect the Bidding Documents at the address provided in paragraph 10 from 8:00 a.m. to 5:00 p.m. Monday to Friday excluding holidays.

5. A complete set of Bidding Documents may be purchased by interested Bidders on **March 15, 2017** from the address in the paragraph 10 and upon payment of a non-refundable fee for Bidding Documents in the amount of **FIFTY THOUSAND PESOS** (Php 50,000.00). It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS). However, only Bidders that have paid the non-refundable fee for the Bidding Documents not later than the submission of their bids are qualified to participate in the bidding.

6. The DND Bids and Awards Committee will hold a Pre-Bid Conference on **March 23, 2017 at 10:00 A.M.**, at the DND-BAC Conference Room, Basement, Left Wing, DND Building, Camp General Emilio Aguinaldo, Quezon City, which shall be opened to all interested parties. In case the said date of pre-bid conference and/or bid

opening **falls on a holiday, or a fortuitous event or was announced as a non-working day**, the said event will be held on the next Tuesday or Thursday following the initially set date of event. Late bids shall not be accepted.


7. Bids must be delivered to the address indicated below on or before **April 06, 2017 at 10:00 A. M., at the DND-BAC Conference Room, Basement, Left Wing, DND Building, Camp General Emilio Aguinaldo, Quezon City**. All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 18.

8. Bid opening shall be on **April 06, 2017 at 10:00 A. M.**, at the DND-BAC Conference Room, Basement Right Wing DND Building, Camp General Emilio Aguinaldo, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address indicated below. Late Bids shall not be accepted.

9. The DND BAC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders.
