**INVITATION TO BID**

**Procurement of Spare Parts for the Repair and Maintenance of Harris Handheld and Manpack Radios of the Philippine Army**

1. The **Department of National Defense/Armed Forces of the Philippines (DND/AFP)**, through General Appropriation Act (GAA) RA 10717, Philippine Army Appropriation for Fiscal Year 2016 with ASA NR 2600-2016-0025 dated 24 February 2016 intends to apply the sum of **One Hundred Million, Six Hundred Ten Thousand, Nine Hundred Ninety One Pesos (PHP 100,610,991.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement of One (1) Lot Spare Parts for the Repair and Maintenance of HARRIS Handheld and Manpack Radios of the Philippine Army**. Bids received in excess of the ABC shall be automatically rejected at Bid opening.

2. The DND/AFP now invites bids for the **supply and delivery of One (1) Lot Spare Parts for the Repair and Maintenance of Harris RF5800H-Manpack 20 Watts, HF/SSB Radios and Harris RF5800V-HH 2-5 Watts, VHF/FM Radios of the Philippine Army**. Delivery of the GOODS is required within a period of **one hundred twenty (120) calendar days from receipt of Notice to Proceed**. Bidders should have completed, within the **last five (5) years** from the date of submission and receipt of bids, a single largest similar completed contract equivalent to at least **Twenty-Five percent (25%)** of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly under Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the RIRR of RA 9184.

4. Interested Bidders may obtain further information from DND Bids and Awards Committee (DND BAC) Secretariat and inspect the Bidding Documents at the address given below from **8:00 AM** to 5:00 PM Monday to Friday excluding holidays.

A complete set of Bidding Documents may be purchased by interested Bidders starting from January 16, 2017 from the address below and upon payment

of a non-refundable fee in the amount of **FIFTY THOUSAND PESOS (PHP 50,000.00)** for the Bidding Documents.

It may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

5. The DND BAC will hold a Pre-Bid Conference on **January 24, 2017** at **10:00 A.M.** at the DND BAC Conference Room, Left Wing, Basement, DND Bldg., Camp General Emilio Aguinaldo, Quezon City which shall be open to all interested parties. In case the said date of pre-bid conference and/or bid opening **falls on a holiday, or a fortuitous event or was announced as a non-working day**, the said event will be held on the next Tuesday or Thursday following the initially set date of event. Late bids shall not be accepted.

6. Bids must be delivered to the address below on or before **February 16, 2017** at **10:00 A.M.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **February 16, 2017** at **10:00 A.M.** at DND BAC Conference Room, Left Wing, Basement, DND Bldg., Camp General Emilio Aguinaldo, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late Bids shall not be accepted.

7. The DND/AFP reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
