***Supply and Delivery of DND-Wide Petroleum, Oil and Lubricants (POL)  
Requirements for CY 2018***

1. The Department of National Defense (DND), through the General Appropriations Act (GAA) intends to apply the sum of **Four Billion Five Hundred Forty Nine Million Nineteen Thousand Six Hundred Ninety Two and 76/100 Pesos (P4,549,019,692.76)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of DND-Wide Petroleum, Oil and Lubricants (POL) for CY 2018. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The DND now invites bids for the DND-Wide Petroleum requirements for CY2018. Delivery of the Goods is required within one calendar year or until the contracted amount is exhausted. Bidders should have completed, within the last five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an Eligible Bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act," and is restricted to Filipino citizens/sole proprietorships, and organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws and regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183).
4. Interested Bidders may obtain further information from the DND Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM Monday to Friday excluding holidays.
5. A complete set of Bidding Documents may be purchased by interested Bidders starting **April 16, 2018** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **SEVENTY FIVE THOUSAND PESOS (Php75,000.00)**.

### **Section I. Invitation to Bid**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The DND will hold a Pre-Bid Conference on **April 24, 2018** to start at **10:00 AM** at DND BAC Conference Room, Right Wing Basement, DND Bldg., Camp General Emilio Aguinaldo, Quezon City, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **May 8, 2018** at **10:00 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **May 8, 2018** at **10:00 AM**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. In case the said date of bid opening falls on a holiday or a fortuitous event or was announced as a non-working day, the bid opening will be held on the next working Tuesday or Thursday, as the case may be. Late bids shall not be accepted.

8. The DND reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
