**INVITATION TO BID**

***Multi-Purpose Attack Craft (MPAC) Mk III Combat System and Capability  
Upgrade Acquisition Project***  
(Lot 2 – Supply, Delivery, and Installation of Mission-Essential Equipment  
and ILS)

1. The *Department of National Defense (DND)*, through the AFP Modernization Act Trust Fund 2017 intends to apply the sum of **SIXTY MILLION PHILIPPINE PESOS (Php60,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Multi-Purpose Attack Craft (MPAC) Mk III Combat System and Capability Upgrade Acquisition Project (Lot 2 – Mission-Essential Equipment and ILS)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Department of National Defense now invites bids for the three (3) sets of **Multi-Purpose Attack Craft (MPAC) Mk III Combat System and Capability Upgrade Acquisition Project (Lot 2 – Mission-Essential Equipment and ILS)**. Please refer to Section VI. Schedule of Requirements for the delivery of the Goods. Bidders should have completed, within *Fifteen (15) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the DND-Bids and Awards Committee Secretariat and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM Monday to Friday excluding holidays.
5. A complete set of Bidding Documents may be acquired by interested Bidders starting **June 7, 2018** from the address below and upon payment of a non-refundable fee in amounts pursuant to the latest Guidelines issued by the GPPB, in the amount of **FIFTY THOUSAND PESOS (Php50,000.00)**.


It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The DND BAC will hold a Pre-Bid Conference on **June 14, 2018 at 10:00 AM** at DND BAC Conference Room, Right Wing Basement, DND Building, Camp General Emilio Aguinaldo, Quezon City, which shall be open to prospective bidders.
7. Bids must be duly received by the DND BAC Secretariat at the address below on or before **June 28, 2018 at 10:00 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 17.1.

Bid opening shall be conducted on **June 28, 2018 at 10:00 AM** at the DND BAC Conference Room, Right Wing Basement, DND Building, Camp General Emilio Aguinaldo, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend the opening. In case the said date of bid opening falls on a holiday or a fortuitous event or was announced as a non-working day, the bid opening will be held on the next working Tuesday or Thursday, as the case may be. **Late bids shall not be accepted.**

8. Bidders shall drop their duly accomplished eligibility requirements, technical and financial proposals in two separate sealed envelopes in the designated bid box located at the Bidding Room.
9. This project is exempted from Customs Duties pursuant to Section 17 RA 10349. VAT payment will be in accordance to Sec. 15.b.ii, General Provisions of the NEP FY 2018.
10. The DND BAC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
