**INVITATION TO BID FOR**  
**Frigate Acquisition Project Lot2C Sublot-2 (30mm Ammunition) for**  
**the Philippine Navy (2<sup>nd</sup> Rebidding)**

1. The Department of National Defense-Philippine Navy (DND-PN), through the AFP MODERNIZATION TRUST FUND intends to apply the sum of **ONE HUNDRED FOURTEEN MILLION ONE HUNDRED FORTY SEVEN THOUSAND TWO HUNDRED FIFTY SIX PESOS (PHP114,147,256.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Frigate Acquisition Project Lot 2C Sublot-2 (30mm Ammunition). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The DND-PN now invites bids for the Frigate Acquisition Project Lot2C Sublot-2 (30mm Ammunition). Delivery of the Goods is required within **Three Hundred Sixty (360) calendar days** from the receipt of Notice to Proceed by the supplier. Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. For this purpose, similar contracts shall refer to the Manufacture and Delivery of 30mm naval ammunition. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

4. Interested bidders may obtain further information from *DND-Bids and Awards Committee 1 Secretariat* and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM Monday to Friday excluding holidays.
5. A complete set of Bidding Documents may be purchased by interested Bidders starting **June 10, 2019** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **FIFTY THOUSAND PESOS (Php50,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *DND-PN* will hold a Pre-Bid Conference on **June 18, 2019** to start at **10:00 AM** at DND-BAC Conference Room, Basement, Left Wing, DND Bldg., Camp General Emilio Aguinaldo, Quezon City, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **July 2, 2019 at 10:00 A.M.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **July 2, 2019 at 10:00 A.M.** at DND-BAC Conference Room, Basement, Left Wing, DND Bldg., Camp General Emilio Aguinaldo, Quezon City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. In case the said date of bid opening falls on a holiday or a fortuitous event or was announced as a non-working day, the bid opening will be held on the next working Tuesday or Thursday, as the case may be. Late bids shall not be accepted.

8. The HOPE reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders. Further, the HOPE reserves the same right, if the funds/allotments for said program/project/activity have been withheld or reduced through no fault of its own.
