**RESOLUTION NO. DND/PAF/PN(PMC)-LARSU-18-R-003**

***“A Resolution Declaring Larsen and Toubro Ltd. as the Single Calculated and Responsive Bidder (SCRB) for the Light Armor System Upgrade (LARSU) Acquisition Project of the Philippine Navy and Philippine Air Force and Recommending the Issuance of a Notice of Award in its favor”***

**WHEREAS**, on 28 August 2018, the Secretary of National Defense (SND) issued Acquisition Decision Memorandum (ADM) No. 2017-076-A directing the Implementation of the LARSU Acquisition Project of the Philippine Navy and the Philippine Air Force with an Approved Budget for the Contract (ABC) in the amount of PhP711,938,000.00, which shall be procured through Public Bidding;

**WHEREAS**, after the conduct of necessary bidding procedures, the DND Bids and Awards Committee 1 (“Committee,” for brevity) conducted the Submission, Opening and Bid Evaluation (SOBE) for the rebidding of the project on 6 December 2018 which was solely participated by Larsen & Toubro Limited;

**WHEREAS**, the Committee proceeded with the opening and evaluation of the eligibility and technical documents of Larsen & Toubro Ltd. which was declared as the Single Calculated Bidder (SCB) for the project, with a financial proposal in the amount of PhP711,542,889.00 through Resolution No. DND/PAF/PN(PMC)-LARSU-18-R-001;

**WHEREAS**, the Committee, in compliance with the provision of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (R.A. 9184) issued in Resolution No. DND/PAF/PN(PMC)-LARSU-18-R-002 dated 6 December 2018 directing the TWG to conduct the post-qualification evaluation on Larsen & Toubro Ltd. to determine the responsiveness of the submitted legal, technical and financial requirements;

**WHEREAS**, the PQ Team, headed by BGEN ARNOLD F FERNANDEZ AFP, conducted the post-qualification on Larsen & Toubro Ltd. from 16-21 December 2018 at its head office and manufacturing plants in India to verify, validate and ascertain all statements and submitted documents of Larsen & Toubro Ltd. during the SOBE;

**WHEREAS**, on 7 January 2019, the PQ Team presented its PQ report and found that Larsen & Toubro Ltd. complied with and is responsive to all the requirements set forth in the Bidding Documents and recommended to the Committee that it be declared as post-qualified and the Single

Calculated and Responsive Bidder (SCRB) for the project and the subsequent issuance of the Notice of Award in favor of Larsen & Toubro Ltd.;

**NOW, THEREFORE**, we, the members of the DND Bids and Award Committee 1, resolve, as it is hereby **RESOLVED**, to approve and adopt the following recommendations of the PQ Team:

- a) to declare Larsen & Toubro Ltd. as post-qualified;
- b) to declare Larsen & Toubro Ltd. as the Single Calculated and Responsive Bidder (SCRB) with a bid price in the amount of PhP711,542,889.00 for the Light Armor System Upgrade (LARSU) Acquisition Project of the Philippine Navy and Philippine Air Force; and
- c) to recommend to the Secretary of National Defense the issuance of a Notice of Award in its favor.
