**RESOLUTION NO. DND/PN-FAP-L2B-SAM-19-R-03**

***“A Resolution Declaring the Proposal of MBDA France as the Single Calculated and Responsive Quotation for the Acquisition of Frigate Lot 2 (Missiles and Munition) – Lot 2B Surface to Air Missile Project of the Philippine Navy and Recommending the Issuance of a Notice of Award in its Favor”***

**WHEREAS**, on 23 April 2018, the Secretary of National Defense (SND) issued amended Acquisition Decision Memorandum (ADM) No. 2013-019-A-1 directing the Acquisition of Frigate Lot 2 (Missiles and Munitions), consisting of three (3) sub-lots, with an Approved Budget for the Contract (ABC) in the amount of **PhP2,000,000,000.00**;

**WHEREAS**, the DND Bids and Awards Committee 1 (“Committee”, for brevity), together with the Technical Working Group (TWG), conducted the renegotiation of the project on 6 December 2018 wherein the proposal of MBDA France in the amount of €10,690,000.00 or equivalent to PhP639,262,000.00 at the foreign exchange rate of €1:PhP59.80, within the ABC of PhP670,000,000.00, was declared as the Single Calculated Quotation (SCQ) through Resolution No. DND/PN-FAP-L2B-SAM-18-R-01;

**WHEREAS**, in the same conference, the Committee further approved the Composition of the PQ Team and itinerary as recommended by the TWG of the project pursuant to Resolution No. DND/PN-FAP-L2B-SAM-18-R-02;

**WHEREAS**, the PQ Team, headed by BGEN ADRIAN D SANCHEZ JR AFP, conducted the post-qualification on MBDA France from 15-21 December 2018 at its principal office and manufacturing plants in France to verify, validate and ascertain all statements and submitted documents of MBDA France during the negotiation;

**WHEREAS**, on 7 January 2019, the PQ Team presented its PQ report and found that MBDA France complied with and is responsive to all the requirements set forth in the Terms of Reference and recommended to the Committee that it be declared as post-qualified and its proposal as the Single Calculated and Responsive Quotation (SCRQ) for the project and the subsequent issuance of the Notice of Award in favor of MBDA France;

**NOW, THEREFORE**, we, the members of the Bids and Awards Committee 1, upon the recommendation of the TWG, resolve, as it is hereby **RESOLVED**, to approve the following:




