RESOLUTION NO. DND/PSG-SFDJ-19-R-03

“A Resolution Declaring the Joint Venture of Southcoast Marketing Inc and TRD Consultancy Pte Ltd as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of Nine (9) Sets Shoulder Fired Directional Jammers Project of the Presidential Security Group and Recommending the Issuance of a Notice of Award in its Favor”

WHEREAS, on 01 August 2018, the Secretary of National Defense (SND) issued Acquisition Decision Memorandum (ADM) No. 2018-018 directing the Acquisition of Nine (9) Sets Shoulder Fired Directional Jammers Project for the Presidential Security Group with an Approved Budget for the Contract (ABC) in the amount of **PhP33,750,000.00**, which shall be procured through Direct Contracting pursuant to Section 50 of the Revised Implementing Rules and Regulations of Republic Act No. 9184 (RIRR of RA 9184);

WHEREAS, on 05 November 2018, the SND noted the recommendation of the DND Bids and Awards Committee 1 (“Committee,” for brevity) for the change in the Mode of Procurement from Direct Contracting to Public Bidding;

WHEREAS, the Committee conducted the Submission, Opening and Bid Evaluation (SOBE) thrice on the following dates, namely: 25 October 2018, 29 November 2018 and 15 January 2019, but were declared as failed biddings pursuant to Sections 35.1 (a) and 35.1 (b) of the 2016 RIRR of RA 9184, respectively;

WHEREAS, after the conduct of necessary bidding procedures, the Committee conducted the fourth SOBE on 26 February 2019 which was participated by two (2) bidders, namely: (1) Joint Venture of Southcoast Marketing Inc and TRD Consultancy Pte Ltd and (2) Joint Venture of Safer PH Innovations Inc and NT Service UAB;

WHEREAS, in the same conference, the Committee declared the Joint Venture of Southcoast Marketing Inc and TRD Consultancy Pte Ltd as the Single Calculated Bidder (SCB) with bid proposal in the amount of Php32,446,507.50 while the Joint Venture of Safer PH Innovations Inc and NT Service UAB was declared ineligible to bid for the project for failure to

comply with **Tab B** (Duly signed Statement of all on-going Government and Private Contracts including contracts awarded but not yet started) and **D** (Duly signed NFCC Computation);

WHEREAS, the Committee, in compliance with the provision of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (R.A. 9184) also resolved in Resolution No. DND/PSG-SFDJ-19-R-01 to conduct the post-qualification evaluation of the Joint Venture of Southcoast Marketing Inc and TRD Consultancy Pte Ltd to determine the responsiveness of the submitted legal, technical, and financial requirements;

WHEREAS, the PQ Team, headed by ATTY JUDITO ANGELO C TADEO, conducted the Post-Qualification (PQ) on the Joint Venture of Southcoast Marketing Inc and TRD Consultancy Pte Ltd on 13 March 2019 at its Head Office in Manila and on 12-18 April 2019 at its head office at Old Toh Tuck Road #05-02, I-Biz Centre, Singapore to verify, validate and ascertain all the submitted documents of the Joint Venture of Southcoast Marketing Inc and TRD Consultancy Pte Ltd during the SOBE;

WHEREAS, on 24 April 2019, the PQ Team presented its PQ report and found that the Joint Venture of Southcoast Marketing Inc and TRD Consultancy Pte Ltd complied with and is responsive to all the requirements set forth in the Bidding Documents and recommended to the Committee that it be declared as post-qualified and the Single Calculated and Responsive Bidder (SCRB) for the Procurement of Nine (9) Sets Shoulder Fired Directional Jammers, as well as to issue the Notice of Award in favor of the Joint Venture of Southcoast Marketing Inc and TRD Consultancy Pte Ltd;

NOW, THEREFORE, we, the members of the DND Bids and Awards Committee, hereby resolve, as it is hereby *RESOLVED*, to approve and adopt the following recommendations of the PQ Team:


- a) to declare the Joint Venture of Southcoast Marketing Inc and TRD Consultancy Pte Ltd as post-qualified;

- c) to recommend to the Secretary of National Defense (SND) the issuance of a Notice of Award (NOA) in its favor.
