1	Clause 10, Section V. Special Conditions of the Contract	With reference to Clause no. 10 of the special condition of the contract, we would like to manifest that for international refueling at foreign Naval and Air Bases, the coordination should be made between the Procuring Entity and their foreign counterparts due to the limitations and restriction of commercial fuel providers inside foreign naval and air bases. Lastly, we would like to manifest that the international refueling transactions of the Procuring Entity should be exempted in the computation of the 6.5% RMC.	For international refueling at foreign Naval and Air Bases, the coordination for allowing commercial fuel providers inside foreign naval and air bases is the responsibility of the Procuring Entity thru its Defense Attache. As to the exemption of international refueling transactions from the 6.5% RMC, said proposal is denied. The amount paid for such transaction forms part of the total Contract Price which is subject to the imposition of the 6.5% RMC.
