**INVITATION TO BID**

**Acquisition of Specialized Trucks and Equipment  
(3 Lots) for the Philippine Navy**

1. The Department of National Defense/Armed Forces of the Philippines (DND/AFP), through the DND Quick Response Fund CY 2014, intends to apply the sum of **FIVE MILLION EIGHT HUNDRED THIRTY THOUSAND PESOS (PhP 5,830,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Acquisition of Specialized Trucks and Equipment (3 Lots) for the Philippine Navy**, broken down into following:

The Contract will be awarded by Lots. Bids received in excess of the corresponding ABC per Lot shall be automatically rejected at bid opening.

2. The DND/AFP now invites bids for the **Acquisition of Specialized Trucks and Equipment (3 Lots) for the Philippine Navy**. The guiding principles for this project shall be based on affordability and sustainability while conforming to the requirements of the Philippine Navy in furtherance of accomplishing its mission. Delivery of the **Specialized Trucks and Equipment (3 Lots)** is required within a period of Ninety (90) calendar days for Lot 1. Sixty (60) calendar days for Lot 2 and Lot 3, from the contract effectivity. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through Public Bidding procedures using non-discretionary "pass/fail" criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the RIRR of RA 9184.

4. Interested Bidders may obtain further information from DND Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM Monday to Friday excluding holidays.
