INVITATION TO BID
Acquisition of the Specialized Equipment of the
Philippine Air Force Project

1. The Department of National Defense/Armed Forces of the Philippines (DND/AFP), through the DND Quick Response Fund CY 2014, intends to apply the sum of **Fourteen Million Two Hundred Thirty Four Thousand Eighteen Pesos (PhP 14,234,018.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Acquisition of the Specialized Equipment of the Philippine Air Force**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The DND/AFP now invites bids for the Acquisition of the Specialized Equipment of the Philippine Air Force. The project involves the acquisition of the following:

3. The requirement shall be utilized by the Philippine Air Force in responding to operations in times of disaster and calamity. The guiding principles for this project shall be based on affordability and sustainability while conforming to the requirements of the Philippine Air Force in furtherance of accomplishing its mission. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

4. Bidding will be conducted through Public Bidding procedures using non-discretionary "pass/fail" criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the RIRR of RA 9184.

5. Interested Bidders may obtain further information from DND Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below from 8:00AM to 5:00 PM Monday to Friday excluding holidays. A complete set of Bidding Documents may be acquired by interested Bidders on November 24, 2015 from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB.

6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

7. The DND BAC will hold a Pre-Bid Conference on **December 01, 2015 at 1:00 P.M.** at DND BAC Conference Room, Basement, Left Wing, DND Bldg., Camp General Emilio Aguinaldo, Quezon City, which shall be open to all interested parties who have purchased the Bidding Documents. In case the said date of pre-bid conference and/or bid opening **falls on a holiday, or a fortuitous event or was announced as a non-working day**, the said event will be held on the next Tuesday or Thursday following the initially set date of event. Late bids shall not be accepted.

8. Bids must be delivered to the address below on or before **December 14, 2015 at 1:00 P.M.** All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **December 14, 2015 at 1:00 P.M.** at DND BAC Conference Room, Basement, Left Wing, DND Bldg., Camp General Emilio Aguinaldo, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

9. The DND/AFP reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
