INVITATION TO BID
CONSTRUCTION OF OCD 5 (2-in-1) DRRM FACILITY
AT LEGAZPI CITY, ALBAY

1. The **DEPARTMENT OF NATIONAL DEFENSE/OFFICE OF CIVIL DEFENSE**, through the **DND Bids and Awards Committee** intends to apply the sum of **FORTY SIX MILLION TWO HUNDRED EIGHTY THREE THOUSAND (Php 46,283,000.00)** Philippine Currency, being the Approved Budget for the Contract (ABC) to payments for the Construction of the OCD 5 DRRM (2-in-1) facility. Bids received in excess of ABC shall be automatically rejected during the bid opening.

2. The **DND-OCD** now invites bids from PhilGEPS registered contractors for the **Construction of the OCD 5 (2-in-1) DRRM Facility at Legazpi, Albay**. Completion of the Works requires **240** Calendar Days from the date of issuance of Notice to Proceed (NTP) to undertake the project. Bidders should have constructed and completed, within the past five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

3. Eligible bidders must satisfy the requirements of the Philippine Contractors Accreditation Board (PCAB) with License Category of "A" in General Building Classification and Size Range of Medium B.

4. Bidders should have completed a single contract similar to this Project i.e. having undertaken the construction of two (2) or more storey office facility and other projects equivalent to at least fifty percent (50%) of the ABC adjusted to current prices using the National Statistics Office consumer price index.

5. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184 otherwise known as the "Government Procurement Act".

6. Interested bidders may obtain further information from **DND-BAC Secretariat** and inspect the Bidding Documents at the address stated below from 8:00 AM to 5:00 PM, Monday to Friday excluding holidays.

7. A complete set of Bidding Documents may be purchased by interested Bidders starting **April 21, 2015** from the address stated below and upon payment of a non-refundable fee amounting to **TWENTY FIVE THOUSAND (Php 25,000.00)**, Philippine Currency. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.
