INVITATION TO BID
(Full Motion Flight Simulator Acquisition Project)

The project involves the acquisition of at **least three (3) units Full Motion Flight Simulator** and its **Initial Integrated Logistics Support (ILS)** package. This will allow pilots an almost full sensory experience that can aid in improving flight instruction, enhancing proficiency, minimizing risks associated with emergency procedures training, reducing accidents, filling up downtimes, and saving on aircraft operational and maintenance costs.

1. The Department of National Defense/Armed Forces of the Philippines (DND/AFP), through the AFP Modernization Act Trust Fund, intends to apply the sum of **TWO HUNDRED FORTY SIX MILLION FOUR HUNDRED THIRTY THOUSAND PESOS (Php 246,430,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **three (3) units Full Motion Flight Simulator** and its **Initial Integrated Logistics Support (ILS)** package. Bids received in excess of the ABC shall be automatically rejected at Bid opening.

2. The DND/AFP now invites Bids from eligible Bidders for the Full Motion Flight Simulator Acquisition Project. Delivery of the GOODS is required within a period of **600 calendar days from the opening of Letter of Credit**. The description of an eligible Bidder is contained in Section II of the Bidding documents, ITB.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act," and is restricted to Filipino citizens/sole proprietorships, corporation with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or corporations of a country the laws and regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138). Only Bids from Bidders who pass the eligibility check will be opened. The process for the eligibility check is described in Section II of the Bidding Documents, ITB. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during the post-qualification procedure.

4. Interested Bidders may obtain further information from DND Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below from 8:00AM to 5:00 PM Monday to Friday excluding holidays.

5. A complete set of Bidding Documents may be purchased by interested Bidders commencing on January 14, 2015 from the address below and upon payment of a non-refundable fee in the amount of **Fifty Thousand Pesos (PhP50,000.00)**. The method of payment will be on cash basis only. The Bidding
