Invitation to Bid
Manufacture, Supply and Delivery of Cartridge
5.56mm, Ball, Linked, SS109

1. The Department of National Defense/Armed Forces of the Philippines (DND/AFP), through the FY 2014 General Appropriations and **PHILIPPINE ARMY Appropriation CY 2014 under ASA # 0145 dated 11 Mar 2014**, intends to apply the sum of **Ninety One Million Four Hundred Fifty Six Thousand One Hundred Fifty Four Pesos and Forty Five Centavos (Php91,456,154.45)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Manufacture, Supply and Delivery of 3,049,555 rds Ctg, 5.56mm, Ball, Linked, SS109**. Bids received in excess of the ABC shall be automatically rejected at Bid opening.

2. The DND/AFP now invites bids for the Manufacture, Supply and Delivery of 3,049,555 rds Ctg, 5.56mm, Ball, Linked, SS109. Delivery of the GOODS is required within a period of **one hundred eighty (180) calendar days** from the Opening of Letter of Credit. Bidders should have completed, within the **last five (5) years** from the date of submission and receipt of bids, a single largest similar completed contract equivalent to at least 25% of the ABC. Likewise, only suppliers who are themselves the manufacturer are allowed to bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the RA 9184.

4. Interested Bidders may obtain further information from DND Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM Monday to Friday excluding holidays.

5. A complete set of Bidding Documents may be purchased by interested Bidders on **July 14, 2015** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **FIFTY THOUSAND PESOS (PHP 50,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.
