INVITATION TO BID

**JCPV PHASE 3A ACQUISITION PROJECT
OF THE PHILIPPINE NAVY**

1. The Department of National Defense/Armed Forces of the Philippines (DND/AFP), pursuant to the Revised AFP Modernization Program, intends to apply the sum of **SIX HUNDRED THIRTY MILLION SIX HUNDRED THIRTY SEVEN THOUSAND ONE HUNDRED SIXTY THREE PESOS AND SIXTY CENTAVOS (PhP630,637,163.60)**, being the Approved Budget for the Contract (ABC), for payments under the corresponding contract for the **Jacinto Class Patrol Vessel (JCPV) Phase 3A Acquisition Project of the Philippine Navy**. Bids received in excess of the ABC shall be automatically rejected at the Bid Opening.

2. The DND/AFP now invites bids for eligible Bidders for the **Jacinto Class Patrol Vessel (JCPV) Phase 3A Acquisition Project of the Philippine Navy**, which involves: 1) *The restoration and sustainment of two (2) 76mm guns for two (2) JCPVs and three (3) 25mm gun systems for three (3) JCPVs*; 2) *Delivery of two (2) brand new electro optical fire control systems and sensors for two (2) JCPVs*; and 3) *Supply and delivery of ammunition for the three (3) JCPVs*. Delivery of Goods or the contract duration shall be within *six hundred five (605) calendar days* as per Bidding Documents.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act." Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility as provided in the IRR of RA 9184.

4. Interested Bidders may obtain further information from the DND Bids and Awards Committee Secretariat and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m. Monday to Friday excluding holidays.

5. A complete set of Bidding Documents may be purchased by interested Bidders on **January 20, 2015** also from the aforesated Committee's Secretariat at the address given below upon payment of a non-refundable fee in the amount of Seventy Five Thousand Philippine Pesos (**PhP 75,000.00**) only.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. The DND/AFP will hold a Pre-Bid Conference on **January 27, 2015 at 10:00 A.M.** at the **DND-BAC Conference Room, Right Wing Basement, DND Building, Camp General Emilio Aguinaldo, Quezon City**, which shall be opened to all interested parties.
