INVITATION TO BID

**JCPV PHASE 3B ACQUISITION PROJECT
OF THE PHILIPPINE NAVY**

1. The Department of National Defense/Armed Forces of the Philippines (DND/AFP), through the General Appropriation Act intends to apply the sum of **TWO HUNDRED TWENTY FOUR MILLION PESOS (PhP224,000,000.00)** being the Approved Budget for the Contract (ABC) for the payments under the corresponding contract for the **Jacinto Class Patrol Vessel (JCPV) Phase 3B Acquisition Project of the Philippine Navy**. Bids received in excess of the ABC shall be automatically rejected at the Bid opening.

2. The DND/AFP now invites bids for eligible Bidders for the **Jacinto Class Patrol Vessel (JCPV) Phase 3B Acquisition Project of the Philippine Navy** which involves: 1) The restoration and sustainment of 76mm gun for one (1) JCPV and 2) Upgrade of electro optical fire control systems and sensors for one (1) JCPV. Delivery of Goods or the contract duration shall be within two hundred forty (240) calendar days as per Bidding Documents.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

4. Interested Bidders may obtain further information from DND-BAC Secretariat and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m. **Monday to Friday excluding holidays**.

5. A complete set of Bidding Documents may be purchased by interested Bidders on **January 20, 2015** from the address below upon payment of a non-refundable fee for the Bidding Documents in the amount of Fifty Thousand Pesos (**PhP 50,000.00**) only.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. The DND/AFP will hold a Pre-Bid Conference on **January 27, 2015 at 11:30 A.M.** at the **DND-BAC Conference Room, Right Wing Basement, DND Building, Camp General Emilio Aguinaldo, Quezon City**, which shall be opened to all interested parties.
