INVITATION TO BID

Procurement of Spare Parts for the Recovery of Huey II Helicopter with Tail Number 662 (Phase 2) of the Philippine Air Force

1. The Department of National Defense/Armed Forces of the Philippines (DND/AFP), through the DND Quick Response Fund CY 2014, intends to apply the sum of **FORTY THREE MILLION ONE HUNDRED EIGHTY NINE THOUSAND SIX HUNDRED THIRTY SIX AND 10/100 PHILIPPINE PESOS (PhP43,189,636.10)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement of Aircraft Parts for the Recovery of Huey II Helicopter with Tail Number 662 Project (Phase 2)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The DND/AFP now invites bids for the Procurement of 158 line items of aircraft parts for use in the Recovery of Huey II Helicopter with Tail No 662. This aircraft will be used for Humanitarian Assistance and Disaster Response (HADR). The guiding principles for this project shall be based on affordability and sustainability while conforming to the requirements of the Philippine Air Force in furtherance of accomplishing its mission. Delivery of the aircraft parts is required within a period of sixty (60) calendar days for line Item #1(T53-L-703) and forty five (45) calendar days for the remaining 157 line items upon issuance of Notice to Proceed. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through Public Bidding procedures using non-discretionary "pass/fail" criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA) 9184, otherwise known as the "*Government Procurement Reform Act*". Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the RIRR of RA 9184.
4. Interested Bidders may obtain further information from DND Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below from 8:00AM to 5:00 PM Monday to Friday excluding holidays. A complete set of Bidding Documents may be acquired by interested Bidders on April 21, 2015 from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **TWENTY FIVE THOUSAND PESOS (PhP25,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.
