All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its revised Implementing Rules and Regulations (IRR).
- VI. All prospective bidders are encouraged to apply for a Certificate of Eligibility on or before five (5) days prior to the scheduled submission and opening of bids.
- VII. The DND assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.
- VIII. The DND reserves the right to reject any or all bids, waive any formality and award the Contract to the bidder whose proposal is the most advantageous to the government as may have evaluated by the Committee.
