**SUPPLEMENTAL BID BULLETIN No. DND-P-GS-02-2015**

This Supplemental Bid Bulletin (SBB) Nr. DND-P-GS-02-2015 is issued to amend, modify and/or clarify items in Bidding Documents for the procurement of Goods for CY 2015 of the Department of National Defense (DND) – Proper, as published in the Philippine Daily Inquirer and posted in the websites of the DND and PHILGEPS. It shall form an integral part of the Bidding Documents.

The following are the amended items:

Section VII, Technical Specifications shall be read as:

4. **DND Wrapping Paper** - 1000 pcs
- Texture: Gift Wrap paper with Multi Color Offset Printing
  - Substance: **150 gsm**
  - Sheets: A) Sizes: 22" x 34"
  - Packing: 500 sheets per ream
  - Design: Customized Design for approval
  - Interested proponent are required to bring product sample to be evaluated as part of reference
  - In accordance with the Terms of Reference



5. **Folding Umbrella** -750 pcs
- Frame: High Quality Metal Shaft and Fiber Glass Ribs
  - Fabric: High Quality Pongee 190T with Silver Backing
  - Color: Blue
  - Size: 42 inches
  - Function: Folding Automatic Open & Close
  - Handle: Rubber handle with carry sling
  - Design: Digital Graphic inlay, not silk screen (DND website only in one panel and seal at the opposite panel)
  - Packing: Pongee carry bag with sling and round adjuster
  - Windproof; sunshade; rainproof; decoration & durable
  - Free delivery
  - Interested proponent are required to bring product sample to be evaluated as part of reference.

## **ADDITIONAL AMENDMENT TO ALL BIDDING DOCUMENTS**

1. Section II, Instruction to Bidders, Clause 18.1 shall be read as "The procuring entity shall prescribe in the BDS the acceptable forms for bid security that bidders may opt to use, which shall include the Bid Securing Declaration (sample form is attached for reference) duly notarized, or other form, the amount of which shall be equal to a percentage of the ABC in accordance with the following schedule:"
2. Section III, Bid Data Sheet, ITB Clause 5.4 "The Bidder must have completed, within the period specified in the Invitation to Bid and ITB Clause 1.2(a)(iii), a single largest completed contract that is similar to this Project, must be at least fifty percent (50%) of the ABC". Similar projects are those items that pertain to the same category of the project and not to the specific brand being carried by a particular supplier.
3. Submission of 2014 Mayor's Permit/Municipal License together with an Official Receipt (OR) evidencing payment for 2015 Mayor's Permit should be submitted in the absence of a 2015 Mayor's Permit. However, a valid 2015 Mayor's Permit/Municipal License must be submitted during the Post-Qualification.
