## INVITATION TO BID

### **Fighter/Surface Attack/Lead-in Fighter Trainer (F/SA/LIFT) Aircraft Munitions (Lots 3 & 4) Acquisition Project**

#### **I. Lot 3 (Countermeasures)**

The Department of National Defense/Armed Forces of the Philippines (DND/AFP), through the AFP Modernization Act Trust Fund (RA 10349 "Revised AFP Modernization Program" dated 11 December 2012), intends to apply the sum of **THIRTY THREE MILLION SEVEN HUNDRED TWO THOUSAND TWO HUNDRED AND EIGHTY SIX PESOS (PHP33,702,286.00)** being the Approved Budget for the Contract (ABC) for the payments under the corresponding contract for the **PAF Acquisition of Fighter/Surface Attack/Lead-in Fighter Trainer (F/SA/LIFT) Aircraft COUNTERMEASURES Project**. Bids received in excess of the ABC shall be automatically rejected at the Bid opening.

The DND/AFP now invites bids for the acquisition of **Seventeen Thousand Two Hundred Eighty (17,280) RR-170 Chaffs and Eight Thousand Six Hundred Forty (8,640) MJU-7 IR Flares (with impulse cartridges)** for the *Countermeasure Dispenser System (Elbit Elisra SPS-45v5EX)* installed in the *FA-50PH Aircraft* with the corresponding **Initial Integrated Logistics Support (IILS)** for the Philippine Air Force. Delivery of the GOODS shall be in two batches. The first batch shall be delivered within one hundred eighty (180) calendar days period from the receipt of Notice to Proceed and the second batch shall be delivered within three hundred sixty (360) calendar days. Bidders should have completed, within the last *ten (10)* years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

#### **II. Lot-4 (20 MM Ammunitions)**

The Department of National Defense/Armed Forces of the Philippines (DND/AFP), through the AFP Modernization Act Trust Fund (RA 10349 "Revised AFP Modernization Program" dated 11 December 2012) intends to apply

the sum of **ONE HUNDRED SIX MILLION ONE HUNDRED THIRTY EIGHT THOUSAND EIGHT HUNDRED PESOS ONLY (Php106,138,800.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **PAF Acquisition of Fighter/Surface Attack /Lead-In Fighter Trainer (F/SA/LIFT) Aircraft 20 MM AMMUNITIONS Project**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The DND/AFP now invites bids for the *acquisition of **Ninety Three Thousand Six Hundred (93,600) rounds of 20 MM Ammunition for the modified A50 Gun System of GD-OTS installed in the FA-50PH Aircraft** with the corresponding **Initial Integrated Logistics Support (IILS)** for the Philippine Air Force*. Delivery of the GOODS shall be in two batches. The first batch shall be delivered within one hundred eighty (180) calendar day's period from the receipt of Notice to Proceed and the second batch shall be delivered within three hundred sixty (360) calendar days. Bidders should have completed, within the last *ten (10) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

1. Bidding for **Lots 3 & 4** will be conducted through Public Bidding procedures using non-discretionary "pass/fail" criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA) 9184, otherwise known as the "*Government Procurement Reform Act*". Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
2. Interested bidders may obtain further information from DND Bids and Awards Committee (DND SBAC) Secretariat and inspect the Bidding Documents at the address given below from Monday to Friday excluding holidays at 8:00 AM to 5:00 PM.
3. A complete set of Bidding Documents may be purchased by interested Bidders on **29 December 2015** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of TWENTY FIVE THOUSAND PESOS (PHP25,000.00) for **Lot 3** and FIFTY THOUSAND PESOS (PHP50,000.00) for **Lot 4**. It may also be downloaded free of charge from the websites of the Philippine Government Electronic Procurement System (PhilGEPS) and the Department of National Defense, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.
4. The DND SBAC will hold a Pre-Bid Conference on **06 January 2016 (Lot 3 - 9:00 AM, Lot 4 - 11:00 AM)** at DND BAC Conference Room, Basement, Right Wing, DND Bldg., Camp General Emilio Aguinaldo, Quezon City, which shall be open to all interested parties who have purchased the Bidding Documents.
5. Bids must be delivered to the address below on or before **18 January 2016**. All Bids must be accompanied by a Bid Security

in any of the acceptable forms as provided in the bidding documents.

6. Bid opening shall be on **18 January 2016 (Lot 3 - 10:00 AM, Lot 4 - 1:00 PM)** at DND BAC Conference Room, Basement, DND Bldg., Camp General Emilio Aguinaldo, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
7. To facilitate eligibility checking, interested bidders are highly encouraged to apply for registration with the DND SBAC, through the SBAC Secretariat not later than ten (10) days from the scheduled submission and opening of bids for the project.
8. The GOODS being offered must be used by the Armed Forces of the country of origin or by the Armed Forces of at least two (2) other countries. The GOODS offered must be from suppliers who are themselves the manufacturers.
9. This project is exempted from Value-Added Tax and Customs Duties pursuant to Section 10 of RA 10349.
10. The DND DND/AFP reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
