





**Lot 2 – Mt. Salakot Air Station and Antonio Bautista Air Station**

1. The Department of National Defense/Armed Forces of the Philippines (DND/AFP), through the CY 2016 Appropriations for AFP Modernization Projects, intends to apply the sum of TWO HUNDRED FIFTY THREE MILLION THREE HUNDRED NINETY TWO THOUSAND FIVE HUNDRED NINETY ONE AND EIGHTY FIVE CENTAVOS (**PHP 253, 392,591.85**) PESOS being the Approved Budget for the Contract (ABC) to payments under the contract for the **Site development of Mt Salakot to include Antonio Bautista Air Base, Puerto Princesa City Palawan including rehabilitations/repairs of facilities and new constructions and other requirements.** Bids received in excess of the ABC shall be automatically rejected during the bid opening.
2. The DND/AFP now invites bids for eligible Bidders for the repair/rehabilitation of facilities and new construction and other requirements. The project involves the construction and rehab/repair of different facilities at Mt Salakot to include Antonio Bautista Air Base, Puerto Princesa City Palawan. Completion of the Works requires **Eight Hundred Ten (810) Calendar Days for Mt Salakot** upon receipt of Notice to Proceed (NTP). Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in ITB Clause 5.1.
3. Eligible bidders must satisfy the requirements of the Philippine Contractors Accreditation Board (PCAB) license with at least License Category of "AA", in General Engineering, General Building and Specialty Classification.



4. In case of a Joint Venture, Special PCAB License for JV must satisfy the required PCAB license with at least License Category of "AA", in General Engineering, General Building and Specialty Classification.
5. Eligible bidders should be construction-oriented, affiliated group of professionals, who can successfully prepare "The Project". They should have experience and capability in the type of services, and the field under consideration, specifically on the repair/rehab and construction of the different facilities under the Radar Basing and Support System Project and Other Requirements.
6. Bidders should have completed a single completed similar contract equivalent to a least fifty percent (50%) of the ABC.
7. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulation (IRR) of Republic Act (RA) 9184 otherwise known as the "Government Procurement Act".
8. Prospective bidders shall be required to submit their bids using the forms specified in the Bidding Documents in two (2) separate sealed bid envelopes which shall be submitted simultaneously. The first shall contain the eligibility and technical component of the bid under Sec. 23.1 of the IRR. The second envelope shall contain the financial component of the bid.
9. The Department of National Defense – Special Bids and Awards Committee (DND-SBAC) shall then proceed with the bid evaluation in accordance with the procedures and timelines described in the competitive bidding pursuant to the revised Implementing Rules and Regulations (IRR) of RA 9184 and rank the bidders from lowest to the highest in order to determine the Lowest Calculated Bid (LCB).
10. Interested bidders may obtain further information from DND SBAC Secretariat and inspect the Bidding Documents at the address given from 8:00 AM to 5:00 PM, Monday to Friday excluding holidays.
11. A complete set of Bidding Documents may be purchased by interested Bidders from 9:00 AM to 5:00PM of **04 May 2016** from the address below and upon payment of a non-refundable fee amounting to **FIFTY THOUSAND PESOS (PhP50,000.00)**, Philippine Currency. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.
12. The DND SBAC will hold a Pre-Bid Conference on **13 May 2016** 10:00 at DND BAC Conference Room, Right Wing Basement, DND Bldg., Camp General Emilio Aguinaldo, Quezon City, which shall be opened to all interested parties





who have purchased the Bidding Documents.

13. Bids must be delivered to the address below on or before **27 May 2016 9:00 AM**.
14. Bid opening shall be on **27 May 2016 10:00 AM** at DND SBAC Conference Room, Right Wing Basement, DND Bldg., Camp General Emilio Aguinaldo, Quezon City. Bids will be opened in the presence of the Bidders representatives who choose to attend at the address below. Late Bids shall not be accepted.
15. To facilitate eligibility checking, prospective bidders may submit their Letter of Intent to participate in the public bidding and further apply for registration with DND SBAC through the DND SBAC Secretariat at least ten (10) calendar days prior to the scheduled submission and opening of bids.
16. The DND-AFP reserves the right to accept or reject any bid, to annul the bidding process and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
