- The Department of National Defense/Armed Forces of the Philippines (DND/AFP), through the AFP Modernization Act Trust Fund (RA 10349 “Revised AFP Modernization Program” dated 11 December 2012), intends to apply the sum of **SEVENTY EIGHT MILLION SEVEN HUNDRED THOUSAND PHILIPPINE PESOS (PhP78,700,00.00)** being the Total Approved Budget for the Contract (ABC) to payments under the contract for the **Medium Lift Fixed Wing Aircraft (C295) Additional Integrated Logistics Support Project (Lot 1 and Lot 2)** with details as shown below:

The guiding principles for this project shall be based on affordability and sustainability while conforming to the requirements of the Philippine Air Force in furtherance of accomplishing its mission.	Sixty (60) calendar days from the contract effectivity. Bidders should have completed within five (5) years before the date of submission and receipt of bids, at least two (2) contracts similar to the Project.

- Bidding will be conducted through Public Bidding procedures using non-discretionary “pass/fail” criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA) 9184, otherwise known as the “*Government Procurement Reform Act*.” Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the RIRR of RA 9184.

3. Interested Bidders may obtain further information from DND Special Bids and Awards Committee (SBAC) Secretariat and inspect the Bidding Documents at the address given below from 8:00AM to 5:00 PM Monday to Friday excluding holidays. A complete set of Bidding Documents may be acquired by interested Bidders on **April 22, 2016** from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **TWENTY FIVE THOUSAND PESOS (PhP 25,000.00)** per lot. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.
4. The DND SBAC will hold a Pre-Bid Conference on **April 29, 2016, 10:00 A.M.** at DND BAC Conference Room, Basement, Right Wing, DND Bldg., Camp General Emilio Aguinaldo, Quezon City which shall be open to all interested parties who have purchased the Bidding Documents.
5. Bids must be delivered to the address below on or before **May 11, 2016, 10:00 A.M.** at DND BAC Conference Room, Basement, Right Wing, DND Bldg., Camp General Emilio Aguinaldo, Quezon City. All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.
6. Bid opening shall be on **May 11, 2016, 10:00 A.M.** at DND BAC Conference Room, Basement, Right Wing, DND Bldg., Camp General Emilio Aguinaldo, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted. 7. To facilitate eligibility checking, interested bidders may apply for registration with the DND SBAC, through the SBAC Secretariat not later than ten (10) days from the scheduled submission and opening of bids for the Project.
8. The DND/AFP reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
