INVITATION TO BID FOR PAF LRPA Basing and Hangarage Project

1. The Department of National Defense/Armed Forces of the Philippines (DND/AFP), through the General Appropriations Act and the AFP Modernization Act, intends to apply the sum of **ONE HUNDRED EIGHTY SEVEN MILLION FOUR HUNDRED THIRTY THOUSAND PESOS (PHP 187,430,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Construction of the three (3) PAF LRPA Basing and Hangarage Project including Other Requirements**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The DND/AFP now invites bids for eligible Bidders for the construction of three LRPA Basing and Hangarage and delivery of other requirements. *The project involves the construction of one (1) unit each of LRPA Basing and Hangarage at Fernando Air Base, Lipa City, Batangas, Antonio Bautista Air Base, Puerto Princesa City, Palawan and Edwin Andrews Air Base, Zamboanga City and delivery of Other Requirements*. The plan is to upgrade the capability requirements of the PAF and improve the operational effectiveness by constructing hangars and facilities that will serve as support systems to address the challenges to territorial integrity, maritime security, natural disasters and internal security. Completion of the Project is required within a period of three hundred (300) calendar days upon receipt of the Notice to Proceed. Bidders should have completed a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding shall be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
4. Interested bidders shall obtain further information from DND Special Bids and Awards Committee (SBAC) Secretariat and inspect the Bidding Documents at the address given below from Monday to Friday excluding holidays at 8:00AM to 5:00 PM.

A complete set of Bidding Documents may be purchased by interested Bidders on **19 January 2016** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **FIFTY THOUSAND PESOS (Php50,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that to be able to participate in the bidding, Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the date of submission of their bids.

5. The DND SBAC shall hold a Pre-Bid Conference on **26 January 2016, 10:00 AM** at DND BAC Conference Room, Right Wing Basement, DND Bldg., Camp General Emilio Aguinaldo, Quezon City, which shall be open to all interested parties.
6. Bids shall be delivered to the address below on or before **08 February 2016 10:00 AM**. All Bids shall be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **08 February 2016, 10:00 AM** at DND BAC Conference Room, Right Wing Basement, DND Bldg., Camp General Emilio Aguinaldo, Quezon City. Bids shall be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. To facilitate eligibility checking, interested bidders may apply for registration with the DND SBAC, through the SBAC Secretariat not later than ten (10) days from the scheduled submission and opening of bids for the project.
8. The DND/AFP reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
