1	During the pre-bid conference, it was specified that supplier's would be allowed to present a Special Bank Line of Credit as an alternative to satisfy the requirement for a statement of Net Financial Contracting Capability as specified in Section II, Paragraph 5.5 of the ITB. The company wishes to thank the SBAC for clarifying in an SBB that this Line of Credit was to be in the amount of 10% of contract value and has two further questions related to this Bank Line of Credit: a. Textron Aviation, Incorporated a fully owned subsidiary of Textron Corporation, will be submitting the CAS aircraft program in this round. Will a Parent Guarantee of contract	Section III. Will a Line of Credit issued by a US based Universal Bank with branches in the Philippines adequately satisfy this requirement?

1	a. A committed line of credit equivalent to ten percent (10%) of the ABC and not ten percent (10%) of contract value from the Textron Aviation, Inc. (the bidder) will suffice. Hence, a Parent Guarantee from Textron Corporation is no longer necessary.	Section III. Bid Data Sheet Item 12.1. Eligibility
	b. Under RA No. 9184 in case of a credit line certificate issued by a foreign Universal or Commercial Bank it shall be confirmed by a local Universal or Commercial Bank. Thus, the committed line of credit issued by a US based Universal Bank with branches in the Philippines the same still needs the confirmation or authentication by a Universal or Commercial Bank in the Philippines.
