

***“A Resolution Declaring Rohde and Schwarz (Philippines) Inc. as the Single Calculated and Responsive Bidder and Further Recommending the Issuance of a Notice of Award (NOA) for the Philippine Air Force Command, Control, Communications, Computers, Intelligence, Surveillance, Targeting Acquisition and Reconnaissance (C4ISTAR) Phase 1 Project Lot 2 (Ground-to-Air Radio Communication System).”***

**WHEREAS**, Acquisition Decision Memorandum No. 2018-025 dated 28 August 2018 was issued by the Secretary of National Defense for Philippine Air Force Command, Control, Communications, Computers, Intelligence, Surveillance, Targeting Acquisition and Reconnaissance (C4ISTAR) Phase 1 Project Lot 2 (Ground-to-Air Radio Communication System) with an Approved Budget for the Contract (ABC) of FORTY MILLION PESOS (PhP40,000,000.00)

**WHEREAS**, on 24 October 2018 the DND Bids and Awards Committee 2 (“Committee”) conducted the Pre-Procurement Conference for the project wherein the Technical Working Group (TWG) presented its details and discussed the justifications for the Mode of Procurement by way of Public Bidding pursuant to Republic Act No. 9184;

**WHEREAS**, on 16 November 2018 the Committee and the TWG conducted a Pre-Bidding Conference;

**WHEREAS**, on 05 December 2018 the Committee and the TWG conducted the Submission, Opening, and Bid Evaluation (SOBE) of the bid tendered in the said project to which Rhode and Schwarz (Philippines) Inc. was the only one who tendered his respective bid for the said lot of the project;

**WHEREAS**, during the SOBE the Committee and the TWG declared Rhode and Schwarz (Philippines) Inc. to be eligible to bid;

**WHEREAS**, on 14 December 2018 the Committee and the TWG declared Rhode and Schwarz (Philippines) Inc. as the Single Calculated Bidder after the evaluation of the Eligibility and Technical Requirements and Financial Proposal;

**WHEREAS**, on 18 December 2018 the Committee and the TWG headed by COL JESUS NELSON B MORALES PAF (GSC) conducted a Post-Qualification of

Rohde and Schwarz (Philippines) Inc. at their Office at 16F BDO Equitable Bank Tower, 8751 Paseo de Roxas Avenue, Makati City;

**WHEREAS**, the TWG presented to the Committee on 20 December 2018 the Post-Qualification result and subsequently recommended the following:

1. Declare Rohde and Schwarz (Philippines) Inc. as the Single Calculated and Responsive Bidder; and
2. Recommend to the Secretary of National Defense the issuance of a Notice of Award (NOA) in favor of Rohde and Schwarz (Philippines) Inc.

**NOW THEREFORE, WE**, the Committee hereby **RESOLVED** as it is hereby **RESOLVED**, to adopt the following;

1. Declare Rohde and Schwarz (Philippines) Inc. as the Single Calculated and Responsive Bidder; and
2. Recommend to the Secretary of National Defense the issuance of a Notice of Award (NOA) in favor of Rohde and Schwarz (Philippines) Inc.
