RESOLUTION NO. DND/PN-FAP2C2-19-R3-05

“A Resolution Declaring Nammo Palencia SLU as the Single Calculated and Responsive Bidder (SCRB) for the Frigate Acquisition Project Lot 2C Sublot-2 (30mm Ammunition) of the Philippine Navy”

WHEREAS, on 23 April 2018, the Secretary of National Defense (SND) issued amended Acquisition Decision Memorandum (ADM) No. 2013-019-A-1 directing the Acquisition of Frigate Lot 2 (Missiles and Munitions), consisting of three (3) lots, with a total Approved Budget for the Contract (ABC) in the amount of **Php2,000,000,000.00**;

WHEREAS, after the conduct of necessary bidding procedures, the DND Bids and Awards Committee 1 (“Committee,” for brevity) conducted the 4th Submission and Opening of Bid Envelopes (SOBE) on 20 August 2019 wherein Nammo Palencia SLU was declared as the Single Calculated Bidder (SCB) through Resolution No. DND/PN-FAP2C2-19-R3-01;

WHEREAS, on 22 August 2019, the Committee issued Resolution No. DND/PN-FAP2C2-19-R3-02 directing the conduct of post-qualification on Nammo Palencia SLU, as well as the approval of the Composition of the Post-Qualification (PQ) Team and Alternates scheduled anytime between 08 September to 08 October 2019 and the corresponding Post-Qualification Plan;

WHEREAS, USND issued Travel Authority No. 1455 dated 26 September 2019 approving the travel of DIR DINNA ANNA LEE L. CARTUJANO and five (5) others to conduct the post-qualification on Nammo Palencia SLU for a period of seven (7) days, inclusive of travel time, anytime from 27 September to 27 October 2019;

WHEREAS, the PQ Team conducted post-qualification on the Nammo Palencia SLU in Madrid, Spain from 6-12 October 2019 to verify, validate and ascertain all the submitted eligibility documents of the bidder during the SOBE;

WHEREAS, on 17 October 2019, the PQ Team presented its PQ report with findings that Nammo Palencia SLU is compliant and responsive to all the requirements set forth in the bidding documents and recommended to the Committee that it be declared as Post-Qualified and the Single Calculated and Responsive Bidder (SCRB) for the Frigate Acquisition Project Lot 2C Sublot-2 (30mm Ammunition) of the Philippine Navy, as well as the issuance of Notice of Award (NOA) in favor of Nammo Palencia SLU;



- a) to declare Nammo Palencia SLU as post-qualified;
- b) to declare Nammo Palencia as the Single Calculated and Responsive Bidder (SCRB) for the Frigate Acquisition Project Lot 2C Sublot-2 (30mm Ammunition) of the Philippine Navy with a bid price in the amount of 1,912,680Euros or equivalent to PhP110,839,806.00 at the foreign exchange rate of 1Euro:PhP57.95; and
- c) to recommend to the Secretary of National Defense (SND) the issuance of a Notice of Award (NOA) in its favor.


