**INVITATION TO BID FOR THE  
UPGRADING OF VMMC ELECTRICAL SYSTEM (PHASE 2)**

(Project Nr: GAA-VMMC-UVES-R-2019)

1. The Department of National Defense (DND) - Veterans Memorial Medical Center (VMMC), through the 2019 General Appropriation Act of the Government of the Philippines (RA 10964) intend to apply the sum of **ONE HUNDRED TWENTY MILLION PESOS (PHP 120,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Upgrading of VMMC Electrical System (Phase 2). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The DND-VMMC now invites bids for the **Upgrading of VMMC Electrical System (Phase 2)**. Completion of work is within *Three Hundred (300) Calendar Days* from receipt to the Notice to Proceed (NTP). Bidders should have completed a contract similar to the project, equivalent to at least fifty percent (50%) of the ABC adjusted to current prices using the National Statistics Office consumer price index. Similar project means **“construction, installation or rehabilitation of electrical system with a capacity of 1MVA and voltage rating of at least 34.5KV”**. The description of an eligible bidder is contained in Section II. Instructions to Bidders.
3. Bidding is open to all interested bidders. Bidder should be a holder of Philippine Contractors Accreditation Board (**PCAB**) License **SP-EE** with Size Range of at least **Medium "B" and License Category "A"**.
4. Bidding will be conducted through open competitive bidding using a non-discretionary "pass/fail" criterion for evaluation as specified in the 2016 Revised Implementing Rules and Regulation (Revised IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Act".
5. Interested bidders may obtain further information from DND Bids and Awards Committee 1 (DND BAC 1) Secretariat and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M., Monday to Friday excluding holidays.
6. A complete set of Bidding Documents may be purchased by interested Bidders from the address below starting **13 January 2020** and upon payment of a **non-refundable fee** amounting to **FIFTY THOUSAND PESOS (PHP50,000.00)**, Philippine currency. It may also be downloaded free of

charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the schedule for the opening of bids.

7. Site inspections are allowed for all prospective bidders starting any day from the publication of the bidding documents until the day before the bid opening from 10:00 AM – 12:00NN.

9. Bids must be duly submitted and received by the BAC Secretariat at the address below on or before the schedule of the bid opening on **04 February 2020**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
10. Bids Opening shall be on **04 February 2020, 10:00 A.M.** at the address below. Bids will be opened in the presence of the bidders or their authorized representatives who choose to attend at the address below. Late bids shall not be accepted.
11. The Head of the Procuring Entity (HOPE) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
