**DND BIDS AND AWARDS COMMITTEE 1
RESOLUTION NO. DND/PN-SRLL-19-R-04**

“A Resolution Declaring Arsenal JSCo as the Single Calculated and Responsive Bidder for the Acquisition of Squad Rocket Launcher Light and the Required Ammunition of the Philippine Navy”

WHEREAS, on 18 December 2018, the Secretary of National Defense (SND) issued Acquisition Decision Memorandum (ADM) No. 2018-052 directing the procurement of 702 units Squad Rocket Launcher Light of the Philippine Navy with an Approved Budget for the Contract (ABC) in the amount of Php514,800,000.00 to be procured through Public Bidding;

WHEREAS, the DND Bids and Awards Committee 1 (“Committee,” for brevity), conducted the Submission and Opening of Bid Envelopes (SOBE) on 03 October 2019 wherein Arsenal JSCo was declared as the Single Calculated Bidder (SCB) through Resolution No. DND/PN-SRLL-19-R-01.

WHEREAS, on 10 October 2019, the Committee issued Resolution No. DND/PN-SRLL-19-R-03 directing the conduct of post-qualification on Arsenal JSCo, as well as the approval of the Composition of the Post Qualification Team and Alternates scheduled anytime between 03 November to 03 December 2019 and the corresponding Post-Qualification Plan;

WHEREAS, USND issued Travel Authority No. 1630 dated 22 October 2019 approving the travel of ATTY JUDITO ANGELO C TADEO and four (4) others to conduct the post-qualification on Arsenal JSCo for a period of seven (7) days, inclusive of travel time, anytime from 04 November to 04 December 2019;

WHEREAS, the PQ Team conducted post-qualification on Arsenal JSCo in Bulgaria from 08-16 November 2019 to verify, validate and ascertain all the submitted eligibility documents of the bidder during the SOBE;

WHEREAS, on 21 November 2019, the PQ Team presented its PQ report and found that Arsenal JSCo is compliant and responsive to all the requirements set forth in the bidding documents and recommended to the Committee that it be declared as Post-Qualified and the Single Calculated and Responsive Bidder (SCRB) for the Acquisition of Squad Rocket Launcher Project of the Philippine Navy, as well as the issuance of Notice of Award (NOA) in favor of Arsenal JSCo;


- a) to declare Arsenal JSCo as post-qualified;
