The project involves the acquisition of **PAF Aviation Engineering Equipment Lot Nr 25 - MMV 6W Alum Closed Van Truck w/ Tail Lift**. The plan is to acquire Mission Essential Aviation Engineering Equipment for 355th Aviation Engineer Wing in order to be effective in its Core functions of providing General Engineering, Aviation Engineering Combat Support, and Engineering support during Humanitarian Assistance and Disaster Response.

1. The Department of National Defense/Armed Forces of the Philippines (DND/AFP), through the General Appropriations Act and the AFP Modernization Act Trust Fund SARO Nr BMB-D-18-0113736, intends to apply the sum of **FIVE MILLION PESOS (PhP 5,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the remaining contract for **Lot Item Nr 25**. Bids received in excess of the ABC shall be automatically rejected at Bid opening.

2. The DND/AFP now invites Bids from eligible Bidders for the **Philippine Air Force Aviation Engineering Equipment Acquisition Project**:

The description of an eligible Bidder is contained in Section II of the Bidding documents, ITB.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act," and is restricted to Filipino citizens/sole proprietorships, corporation with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to

citizens or corporations of a country the laws and regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138). Only Bids from Bidders who pass the eligibility check will be opened. The process for the eligibility check is described in Section II of the Bidding Documents, ITB. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during the post-qualification procedure.

4. Interested Bidders may obtain further information from DND Bids and Awards Committee 2 (BAC 2) Secretariat and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM Monday to Friday excluding holidays.

5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee in the amount Five Thousand Pesos (PhP 5,000.00) which allows the Bidders to participate in this Lot. The method of payment will be on cash basis only. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.

Note: Bidders who have previously bought the Bidding Documents are no longer required to buy the Bidding Documents. They can request for a copy of the new Bidding Documents to the DND BAC 2 Secretariat.

6. The AFP/DND will hold a Pre-Bid Conference open to all interested parties on 2PM of 28 Nov 2019 at DND BAC Conference Room, Basement, Right Wing, DND Bldg., Camp General Emilio Aguinaldo, Quezon City.

7. Bids and eligibility requirements must be delivered to the address below before 10AM of 11 Dec 2019. All Bids must be accompanied by a Bid Security in any form and corresponding amount allowed under RA 9184 and its IRR-A. Late bids shall not be accepted.

8. Bid opening shall be on 10AM of 11 Dec 2019 at DND BAC Conference Room, Basement, Right Wing, DND Bldg., Camp General Emilio Aguinaldo, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below.

9. The DND/AFP reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
