***“Resolution Declaring Jinyi Import & Export Trading Co. Inc. as the Single Calculated and Responsive Bidder and Recommending for the Issuance of Notice of Award in its favor for the Procurement of PAF Aviation Engineering Equipment (PAF AEE) Lot Nrs 13, 15, 22, 23, & 24 and as the Lowest Calculated Responsive Bidder for AEE Lot Nr 20.”***

**WHEREAS**, on 20 Nov 2018, the Secretary of National Defense issued Acquisition Decision Memorandum (ADM) No. 2018-020-A, directing the immediate implementation of the acquisition of the following PAF Aviation Engineering Equipment (PAF AEE) Lots with an Approved Budget for the Contract (ABC) as indicated;

Lot Nr 13 – 1unit Compact Backhoe Loader, ABC: Five Million Two Hundred Thousand Pesos (PhP 5,200,000.00)

Lot Nr 15 – 2units 5-ton Single Drum Rollers, ABC: Eight Million Four Hundred Thousand Pesos (PhP 8,400,000.00)

Lot Nr 20 – 8units Self Loading Mixers, ABC: Sixty-Seven Million Two Hundred Thousand Pesos (PhP 67,200,000.00)

Lot Nr 22 – 8units Equipment Haulers (Self-Loaders), ABC: Thirty-Five Million One Hundred Thousand Pesos (PhP 35,100,000.00)

Lot Nr 23 – 2units 10cu.m. Water Trucks, ABC: Seven Million Pesos (PhP 7,000,000.00)

Lot Nr 24 – 2units 12ton capacity & 18m Wrecker Trucks, ABC: Fifteen Million Four Hundred Thousand Pesos (PhP 15,400,000.00)

**WHEREAS**, the Bids and Awards Committee 2 (BAC 2) conducted the Pre-Procurement Conference for the project on 28 Jun 2019 and the Pre Bid Conference on 10 Jul 2019;

**WHEREAS**, on 26 Jul 2019, the BAC 2 conducted the 2<sup>nd</sup> Submission, Opening of Bid and Evaluation wherein a total of Thirteen (13) Bidders had participated for the Thirty (30) remaining Lots of the PAF Aviation Engineering Equipment;

**WHEREAS**, on 02 August 2019, Jinyi Import & Export Trading Co. Inc. was declared by the BAC 2 as eligible to bid for PAF AEE Lot Nrs 12, 16, 20, 22, 23, & 24, however, was declared by the BAC 2 as ineligible to bid for Lot Nrs 13, 15, 27, & 28. The aforementioned company signified its intention to file a Motion for Reconsideration (MR) for the Lots that it was declared as "failed".

**WHEREAS**, on 07 August 2019, the BAC 2 granted the MR filed by Jinyi Import & Export Trading Co. Inc. for Lot Nrs 13 & 15, however, denied the MR for Lot Nrs 27 & 28. On the same date, the opening of the Financial Proposal was conducted with the following amounts which were all rated as "passed":

Lot Nr 12 – two (2) units Skid Steering Mini Backhoe Loader, with Bid Proposal of Eight Million Pesos (PhP 6,950,000.00),

Lot Nr 13 – one (1) unit Compact Backhoe Loader, with Bid Proposal of Eight Million Pesos (PhP 3,950,000.00),

Lot Nr 15 – two (2) units Rollers Single Drum Small, with Bid Proposal of Eight Million Pesos (PhP 6,850,000.00),

Lot Nr 16 – seven (7) units Rollers Tadnem Drum Mini, with Bid Proposal of Six Million Eight Hundred Fifty Thousand Pesos (PhP 15,400,000.00),

Lot Nr 20 – eight (8) units. Self-Loading Mixers, with Bid Proposal of Fifty-One Million Nine Hundred Fifty Thousand Pesos (PhP 51,950,000.00),

Lot Nr 22 – six (6) units Equipment Haulers (Self-Loaders), with Bid Proposal of Thirty-One Million Five Hundred Thousand Pesos (PhP 31,500,000.00),

Lot Nr 23 – two (2) units 10cu.m. Water Trucks, with Bid Proposal of Five Million Eight Hundred Fifty Thousand Pesos (PhP 5,850,000.00) and

Lot Nr 24 – two (2) units 12-ton capacity & 18m Wrecker Trucks, with Bid Proposal of Twelve Million Nine Hundred Fifty Thousand Pesos (PhP 12,950,000.00).

**WHEREAS**, the PAF Aviation Engineering Equipment Technical Working Group (TWG) evaluated the bid of Jinyi Import & Export Trading Co. Inc. and declared the same to be in order and compliant with the requirements of the subject project;

**WHEREAS**, on 16 August 2019, the PAF Aviation Engineering Equipment TWG, after evaluation, recommended to declare Jinyi Import & Export Trading Co. Inc. as the Single Calculated Bidder for the PAF AEE Lot Nr 12, 13, 15, 16, 22, 23, & 24 and as the Lowest Calculated Bidder for the PAF AEE Lot Nr 20;

**WHEREAS**, on 23 August 2019, the Post-Qualification Team conducted the Post-Qualification of Jinyi Import & Export Trading Co. Inc. pursuant to Section 34 of the IRR of RA 9184;

**WHEREAS**, on 30 August 2019, the PQ Team presented to the Committee results of the Post-Qualification and recommended the following:
