***“Resolution Declaring Civic Merchandising Inc. as the Single Calculated and Responsive Bidder and Recommending for the Issuance of Notice of Award in its favor for the Procurement of PAF Aviation Engineering Equipment Lot Nr 8 - 7units 23ton Dozers.”***

**WHEREAS**, on 20 Nov 2018, the Secretary of National Defense issued Acquisition Decision Memorandum (ADM) No. 2018-020-A, directing the immediate implementation of the acquisition of PAF Aviation Engineering Equipment (PAF AEE) Lot Nr 8 - 7units 23ton Dozers with an Approved Budget for the Contract (ABC) of FIFTY-SEVEN MILLION FOUR HUNDRED THOUSAND PESOS (PhP 57,400,000.00);

**WHEREAS**, the Bids and Awards Committee 2 (BAC 2) conducted the Pre-Procurement Conference for the project on 28 Jun 2019 and the Pre Bid Conference on 10 Jul 2019;

**WHEREAS**, on 26 Jul 2019, the BAC 2 conducted the 2<sup>nd</sup> Submission, Opening of Bid and Evaluation wherein a total of Thirteen (13) Bidders had participated for the Thirty (30) remaining Lots of the PAF Aviation Engineering Equipment;

**WHEREAS**, on 02 August 2019, Civic Merchandising Inc. was declared by the BAC 2 as eligible to bid for PAF AEE Lot Nr 8 - 7units 23ton Dozers. Likewise, the BAC 2 also opened the Financial Proposal of the said proponent in the amount of FIFTY-FIVE MILLION EIGHT HUNDRED SIXTY THOUSAND PESOS (PhP 55,860,000.00) and the same was rated as "passed";

**WHEREAS**, the PAF Aviation Engineering Equipment Technical Working Group (TWG) evaluated the bid of Civic Merchandising Inc and declared the same to be in order and compliant with the requirements of the subject project;

**WHEREAS**, the TWG subsequently recommended that Civic Merchandising Inc. be declared as the Single Calculated Bidder for the PAF AEE Lot Nr 8 - 7units 23ton Dozers and the conduct of Post-Qualification of the same;

**WHEREAS**, on 13 August 2019, the Post-Qualification Team conducted the Post-Qualification of Civic Merchandising Inc. pursuant to Section 34 of the IRR of RA 9184;

**WHEREAS**, on 30 August 2019, the PQ Team presented to the Committee the results of the Post-Qualification and recommended the following:

- a) Declare Civic Merchandising Inc. as "Post-Qualified";
- b) Declare Civic Merchandising Inc. with a bid price proposal of FIFTY-FIVE MILLION EIGHT HUNDRED SIXTY THOUSAND PESOS (PhP 55,860,000.00), as the Single Calculated Responsive Bidder (SCRB); and
- c) Issuance of the Notice of Award in favor of Civic Merchandising Inc. for the PAF AEE Lot Nr 8 - 7units 23ton Dozers.

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee 2, hereby **RESOLVE**, as it is hereby **RESOLVED** to approve the recommendations of the PAF Aviation Engineering Equipment TWG to declare Civic Merchandising Inc. to:
